The review will introduce changes that will modernise the Act and identify ways to reduce red tape to ensure WA communities benefit from efficient and effective councils now and into the future.

A consultation paper will be available online from 8 November 2017 and will be available for public comment through online submissions. Following the release of the consultation paper, the Department is holding workshops in a number of locations throughout the State.
