This Association was originally formed in January 1985 and named Canning River Ward Association (Inc). The name of the Association was subsequently changed to Riverton, Rossmoyne & Shelley Residents' Association (Inc) in December 2004 to reflect a broader area of interest and to specifically identify the communities of the Beeliar Ward, within the City of Canning. The Review of Wards and Boundaries in early 2015 means that our Members are now electors of the Bannister Ward.

The RRSRA is a non-political, non-sectarian and not-for-profit organization.

## What do we do?

- Look after and represent the interests of the Residents in Riverton, Rossmoyne and Shelley.
- Encourage everyone to take an interest in our City.
- Make representations and submissions to the Council of the City of Canning on matters concerning residents.

- Work to maintain an equitable rating within the City of Canning
- Members maintain the Rossmoyne Park in conjunction with the Canning City Council.

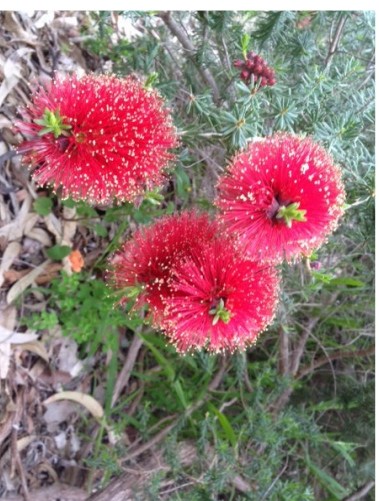
